Lasswell then proposes questions useful for the scientific comparison of parochial ideologies.

"Cooperation for Research in Psychiatry and Law." By Lawrence Zelic Freedman and Harold D. Lasswell. American Journal of Psychiatry 117 (1961): 692-694.

Lasswell and Freedman discuss the relations between lawyers and psychiatrists. They identify four types of problems: communication, professional values, research collaboration, and competency. For each type, the authors briefly illustrate problems and make recommendations for improvements.

Verbatim transcripts of staff-patient meetings are content analyzed using value categories, and suggestions are made about how to improve power sharing.
